

## **From Your Sanctioning Director and Statistician Sue Ferrari**

The only changes you will be seeing from me, as far as sanctioning goes will be in the what you receive back in your sanctioning packet that I mail. There will be fewer copies of the various forms, as we try and keep the postage costs down this year. If there is any way you can receive this packet via email, you are helping your organize save a few \$\$.

Handlers and organizers, please watch your dogs and pulls closely this year. If you find any errors, the sooner you let me know, the better for all involved. When you wait until the end of the whole season, it does cause problems for everyone. You are all doing great at remembering to call your dog the same name, all season.

We will be cleaning up the data base this year. One of the items being changed is the Breed category. If your dog is a mixed breed, of any sort - it will now be listed as mixed or unknown under the breed. If you have a pure bred and by some error it doesn't show this in the listing, please let me know as soon as possible. This is just part of the housekeeping we are going to be doing.

There is one thing I would like to point out to everyone on the Working Dog Degree paperwork. The form actually reads (at an IWPA Sanctioned or IWPA Approved pull) for it to be considered as one of the qualifying pulls. This does mean that pulls at other pulling venues with other groups, probably will not qualify for one of your legs. If you are unsure, please don't hesitate to ask myself or someone else on the Board.

IWPA Board Meeting  
Estes Park, CO  
June 2, 2012

Meeting called to order by President Terry Reed at 8:25 am

Present: Terry Reed, Cheryl Martin, Sue Ferrari, Brenda Lemon and Bob Sencenbaugh

Absent: Ken Blackburn, Stephanie Pitz, David Gallagher

Guest: Robbie Reed, Rodney Martin

**Reports:**

Vice President: Brenda Lemon provided a written report with her observations through the year. She advised most complaints she heard about were in regard to the Web Site.

Secretary: accept the minutes from the 2011 board meeting. MSC

Treasurer: Cheryl Martin provided a written financial report.

Promotions: Brenda Lemon advised she worked with Wendy Leister trying to increase Region 11 Membership. No report in regard to club promotions.

Sanctioning: Sue Ferrari provided a written report. In brief the report indicated there were 126 pulls sanctioned; 2 were Championship Pulls and 6 were fun pulls. One pull needed to be rescheduled due to a death in the immediate family of the organizer. The organizer and others in the area made sure that everyone was aware of the change in date, and had someone at the site both days in case anyone did show up for the event. Additionally all pull request paperwork and money came in a timely fashion. No outstanding problems noted.

Statistician: Sue Ferrari provided a written report. In brief the report indicated all pulls reported back. Three (3) organizers were fined for not having their paperwork and/or fees returned in a timely fashion. Two (2) were at the end of the season causing some delay in getting the information out for the Championship invitation letters. Additionally there are still some issues with what people are naming their dogs at pulls (not using the same name) and what is in the database. As for paperwork submitted by organizers some feel the need to write something on each line of the Finish Report; the biggest issue is putting NP on every line even if the dog simply times out or couldn't complete the pull.

Judges: George Ferrari submitted a written report. In brief the report indicated there were 41 certified judges (the same as last season). Every organizer submitted the Judges Report for all sanctioned pulls. No complaints against any judges filed. There was a complaint about an organizer running a novice class and sanctioned class together at the same time. George addressed this with the organizer. The DQ's were cited for the following reasons; 8 stepped over the line, 7 called/talked to the dog before crossing the finish line, 1 leash thrown, 1 dog touched the handler and 4 handlers touched the dogs. George also noted at one pull the only dogs pulled were the Chief Judge/Organizers. He suggested this is not a good practice and feels this may need to be addressed within the rules.

Standing Rules: Kitty Alvarado, NA

Medals/Awards: Donna Libbey submitted a written report providing the number of Working Dog medals she currently has in stock. Terry Reed provided a written report of the numbers of Regional Medals and Championship Medals in stock including ribbon counts. Donna Libbey indicated she had received about 30 Working Dog Degree Applications.

Elections: Stephanie Pitz, no report submitted, Stephanie e-mailed Secretary Kitty Alvarado that she mailed results but they had not been received as of the board meeting date.

Membership: Rodney Martin provided a written report. In brief the report indicated there were a total of 185 memberships this year; 44 new single, 14 new family, 70 renewing single, 53 renewing family. The membership count this year increased 32 memberships from last year. The membership appears to be taking advantage of the early discounts in that 87 memberships were submitted prior to September 1<sup>st</sup> (over 47 percent) with the remaining being submitted throughout the season.

Championship: Bob Sencenbaugh provided a written report. In brief the report indicated there were a total of 29 entries for the Snow Pull and 45 entries for the Wheel Pull. There were 2 tracks available for the wheel pull however; we used only 1 track to keep the pull running a little longer for Cabela's. The best track and cart were used. The Wheel pull ended about the same time as the snow pull and was not overly prolonged.

Cabela's was very pleased with the Championships. The IWPA raised about \$1200.00 for the Dogs for Diabetes.

Personnel: Bob Sencenbaugh provided a verbal report advising there were no personnel issues this season.

Drug Testing: Robbie Reed provided verbal report in that drug testing was not completed at the Championships.

Drug testing funds are available to be completed in upcoming Championships. Some factors in the decision for not testing this Championship include a possible low turnout and the expense of drug testing (50 tests must be submitted to receive a cost break in testing fees).

Regional Coordinator: Robbie Reed reported she did not have any major issues this season. The only concern was no one in Region 4 came forward after repeated requests for a region rep. Robbie also received Region Meeting Minutes from Region 2. Robbie only received about 6 emails of inquiries on the club; all were sent on to the appropriate Region Reps. Many telephone calls had been received/answered and passed on.

Newsletter: Robbie Reed provided a written report. In brief the report indicated the average annual cost per membership for a Newsletter is \$32.28 which is a very minimal increase from the previous season. One continued issue in producing the newsletter is importing Pull Results in the format that is sent from Sue Ferrari (Statistician). Due to this issue composing the newsletter is very time consuming as nearly each line must be reformatted. Sue and Robbie to work on this program issue in hopes of resolving the problem. Robbie also suggested that obtaining (either renting or purchasing postage/weighing system would help speed up the process in mailing the newsletter. This will be discussed in new business.

Animal Welfare/Education: Ken Blackburn absent and did not submit a written report

Grievance: Dave Gallagher absent and did not submit a written report.

Web Master: Donna Daymude absent and no report submitted. Discussion by the board in regard to complaints they had heard; Website not getting updated soon enough and results posted. Terry Reed reminded everyone and suggested they pass on the Website is not the official notification media, it is the Newsletter. Also the Domain will expire in June; we will need to find a new domain.

Web Site Inquiry: Brenda Lemon submitted a written report. In brief the report indicated Brenda received 29 web site inquiries over the season. Brenda passed on information to the appropriate Region Reps also.

Hall of Fame: Robbie Reed advised the forms have been created. Once the form is approved it will be posted in the newsletter for submissions. Robbie also provided copies of the Certificates proposed for approval. To be discussed under unfinished business.

**New Business:**

President Terry Reed called new business to order.

President Terry Reed thanked Kitty Alvarado for serving many years as the IWPA Secretary.

Board Members present; President Terry Reed, Sue Ferrari, Rodney Martin and Brenda Lemon  
Absent; Stephanie Pitz and George Ferrari. Stephanie was not able to make the meeting but prior to the meeting suggested Bob Sencenbaugh to fill a vacant position as he had submitted his nomination request 1 day late. A suggestion was made to accept Stephanie Pitz motion via proxy for Bob Sencenbaugh to fill a vacant position and Rodney Martin second; MSC.

Bob Sencenbaugh made a motion for Cheryl Martin to fill a vacant position, Sue Ferrari second; MSC.

President Terry Reed stated he had talked to Sean Hammell in Region 3 who said he would be interested in filling a one year board position appointment. Bob Sencenbaugh made a Motion for Sean Hammell to fill one board vacancy, Rodney Martin second MSC.

The 2012-2013 IWPA Board of Directors will be as follows; President Terry Reed, Vice President Bob Sencenbaugh, Treasurer Cheryl Martin, Sue Ferrari, Brenda Lemmon, George Ferrari, Sean Hammell, Stephanie Pitz and Secretary to the Board Robbie Reed.

Cheryl Martin advised she got a receipt from previous Secretary Kitty Alvarado for her internet service reimbursement for \$49.95 (phone/internet/long distance then the bill jumped to \$55.62 for the Feb-March 2012 billing due to the end of a promotional rate. The bill documents charges for each service; local phone service \$35.00, long distance service \$10.00 and internet \$30.00 without the promotional discount. Sue questioned why internet was paid anyway. Terry advised at the Board Meeting held in Nashville, TN Kitty advised the prior board agreed to pay the Secretary’s Internet service. The new board that year voted to pay for the Secretary’s Internet Service within a reasonable amount. Bob Sencenbaugh made a Motion to reimburse Kitty the amount of \$30.00 for each month Internet Service only, not the \$55.62, Brenda Lemon second; MSC.

## Web Master Position

Sheryl Franklin submitted a letter of interest to Brenda Lemon. Sheryl is the owner/operator of Franklin Communications Services. Sheryl feels there are easier and more user friendly ways to access the clubs web site. She has been a weight puller for years and a current IWPA member. Sheryl was advised of the \$100 per month stipend by Brenda Lemon and agrees to this stipend. Cheryl Martin made a motion to use Sheryl Franklin as the Web Master and Bob Sencenbaugh second; MSC.

The paid stipend for statistician was discussed. Sue Ferrari stated she will continue as Statistician if possible. Bob Sencenbaugh made a Motion to keep the stipend at \$100.00 per month (twelve months per year), Rod Martin second; MSC.

Cheryl Martin suggested another position to be paid a stipend should be the Newsletter. Cheryl suggested pay \$100.00 per month (10 months a year) for compensation in the creation and printing/distributing the Newsletter. Cheryl feels the current budget will cover this expense easily. This is a time consuming process and required by our Constitution.

Bob brought up also paying a stipend to the Treasurer. Sue made a motion for the Newsletter Position be paid \$100.00 per month (10 months) and the Treasurer be paid \$100.00 (12 months), Bob Sencenbaugh second; MSC These stipends to begin July 2012.

Sue Ferrari reported the Sanctioning postage in the 2010/2011 season on average cost \$3.75 per packet mailed out; the 2011/2012 season postage went up on average to between \$4.00 to \$5.00 per packet, some as high as \$8.00 dependent on zip code. Sue suggested to mail only 1 copy of each form and the organizers be responsible to make their own copies of each form or increasing the sanctioning fees. After much discussion Sue Ferrari made a Motion for the Sanctioning Director to mail out only one (1) copy of each form to eliminate the need to raise Sanctioning costs, Bob Sencenbaugh second; MSC.

Sue Ferrari as Statistician would like to take the old data base and save it; clean out breeds and dogs start a new database and list the pure breed name and any mix breed as simply "mix". Bob Sencenbaugh made a Motion to purchase 2 external storage devices (8GB) thumb drives (one as a back up database), Brenda Lemon second; MSC.

Brenda Lemon brought up the east coast was trying to pick up new members. Brenda suggested to get younger kids involved and would like to see a Junior program like UKC Junior Program and given their own awards; MWP and BBP. Brenda suggests that organizers provide Junior awards. Brenda will write an article for Newsletter suggesting this. Brenda Lemon brought up Debbie Lee also talking about having the same 2 carts at Championships; IWPA to purchase the 2 carts and have the carts available for use to organizers to rent/borrow. The Board discussion included cost to the club for expense/maintenance and traveling expense which would not be a feasible project.

The Board reviewed all the following Forms with noted changes; Sanctioning, Membership- \$5 discounts continued, Judge renewal form, Working Dog application-IWPA SANCTIONED/APPROVED pull specifies what events would be eligible (Sanctioning to put an article in the Newsletter with further explanation), Judges renewal; change dates and adding if the judge is the only person there pulling they must have someone else judge them, Judge Apprentice Application, Final Results, Judges Report, Handler Meeting sign in, Finish Report (NP defined as dog did not pull starting weight, DQ is a dog disqualified, Weight Pull Score Sheet; delete fail code, Complaint Form, Membership Receipt, Provisional Membership Form, Hall of Fame; add the Chairperson contact information.

The Board discussed the internet for the Secretary position being paid by the IWPA. It was suggested this not be paid any longer. Sue Ferrari made a Motion, Bob Sencenbaugh second; MSC.

Ribbons/Awards purchase discussed; the total number the IWPA has for Regional Silver and Bronze are okay but will need 100 Gold and/or whatever number we would get a price break, Championship Medals we will need to order a full

year 20 each Gold, Silver and Bronze. Also purchase ribbons so all ribbons will appropriately match for the medals we currently have that do not have ribbons. Sue Ferrari made a Motion for purchases, Brenda Lemon second; MSC. The Board discussed purchasing Pitney/Bowes type machines for postage stamping for the Newsletter and Sanctioning. 

## Working Dog Degree Program

Your dog must meet the criteria below to be eligible for the various working dog degrees. When your dog has achieved the required number of pulls for a degree (at an IWPA Sanctioned or IWPA Approved pull) and you have completed the application forms for each pull, send the forms and \$10 for each certificate requested to the Working Dog Chairperson, after September 1 in the following program year. Your certificate will be mailed to the address on the application form. Please complete all blanks on the forms to aid in the processing of the certificates. All pulls required for a certificate must be achieved in no more than two consecutive program years. The program year is from September 1 to August 31 the following year.

### Requirements for Certificates

#### Snow

1. IWPA Working Dog: the dog must pull 5 times its own body weight in 4 different pulls on snow.
2. IWPA Working Dog Excellent: the dog must pull 10 times its own body weight in 4 different pulls on snow.
3. IWPA Working Dog Superior: the dog must pull 15 times its own body weight in 3 different pulls on snow.

#### Wheels

1. IWPA Working Dog: the dog must pull 12 times its own body weight in 4 different pulls on wheels.
2. IWPA Working Dog Excellent: the dog must pull 18 times its own body weight in 4 different pulls on wheels.
3. IWPA Working Dog Superior: the dog must pull 23 times its own body weight in 3 different pulls on wheels.

# INTERNATIONAL WEIGHT PULL ASSOCIATION WEIGHT PULL STANDING RULES ON SANCTIONING

## In order for your pull to be sanctioned and to count for points.

Any organization who wishes to put on a pull approved by the I.W.P.A. shall require the organizer or any of the officials to have an I.W.P.A. membership and use I.W.P.A. weight pull rules which include having an I.W.P.A. certified and approved judge.

A sanctioning application must be filled out by the organizer and delivered into the hands of the I.W.P.A. sanctioning director no later than the 15th of the month preceding the month in which the event is to take place, provided the event is scheduled between the 15th through the end of any given month. Pulls scheduled from the 1st through the 14th of any month must be received no later than the 15th of the month two months prior to the weight pull event. For example, an event scheduled for December 7th must be received no later than October 15th, an event scheduled for December 28th must be received no later than November 15th. **No exceptions to this rule will be made!!** It is the organizer's responsibility to ascertain if this application has been received by the Sanctioning Director.

Newsletter pull calendar information is taken from the sanctioning application; therefore, ALL questions must be answered. It may be considered false advertising for any organizer to falsify or fail to follow the information provided on the sanctioning request. False advertising will be grounds for placing the organizer on probationary sanctioning status.

The following list of information from your weight pull must be sent to the Sanctioning Director with a postmark no later than 5 days after the last day of your pull:

1. Weight Pull finish report
2. Organizer's report
3. Financial report with ALL monies due the IWPA for the \$5.00 per dog fee. For pulls held in Canada \$5.00 are payable in U.S. funds only. (Motion6/07)
4. All regular and provisional membership monies received at your pull with completed membership forms must be sent to the Membership Director with a postmark no later than **5 days** after the last day of your pull. New members are to be given the membership receipt included in your packet as proof of membership until their card is sent to them.
5. Send Judge's Reports to the Judge Chairperson  
(The penalty for failure to meet the 5 day postmark requirement will result in a fine of not less than \$20.00 and \$5.00 per day for each day after 6 days that the pull results are not postmarked. Failure to pay a fine may result in loss of sanctioning and/or points). **Exception—Organizers of pulls held the last two weeks of the season are required to submit finish reports to the sanctioning director and FAX or OVERNIGHT their finish report, finance report, and organizer report to the statistician within one working day. (motion 5/98)**

Any grievances by an organizer or judge should be in writing, postmarked no later than 72 hours after the end of the weight pull event, and sent to the Sanctioning Director who will present the written grievance(s) to the I.W.P.A. Board of Directors **within two weeks of the receipt of the grievance**, for deliberation.

**Sanctioning applications that do not include the sanctioning fees will not be accepted. Exception—When faxing application a copy of the check/money order for sanctioning fees must be faxed with the application. The original application and check/money order for sanctioning fees must be postmarked within one working day of the fax. The original application and payment for sanctioning fees must be received by the sanctioning director no less than one week prior to the event or the sanctioning may be canceled.**

**Organizers of events which have had sanctioning suspended after the pull will be required to mail a reimbursement to all entrants of the \$5.00 per dog fee. This reimbursement must be mailed within 72 hours of the receipt of written notice by the Sanctioning Director of suspended sanctioning. (Failure to reimburse funds when sanctioning has been suspended may mean loss of future sanctioning of event by the organizer)**

**The Board of Directors may not make a decision on sanctioning a pull but will make a decision regarding any grievance filed in regard to sanctioning.**

**If the Sanctioning on a pull is refused or the sanctioning is withdrawn from a pull, the sanctioning director will notify the organizer in writing within 2 days. A phone call or fax is a courtesy but the "in writing" is a requirement.**

**Cancellations of a pull will be accepted with no penalty as long as there is ample time to report the cancellation in the newsletter with the same deadlines as for sanctioning a pull. If these deadlines are not met, the organizer shall (at their own expense) send out postcards to all members to notify them of the cancellation. If this is not one, an organizer may be subject to loss of sanctioning fees. There will be no provisions for "Rain Dates". I have read and understand the above rules regarding sanctioning.**



# International Weight Pull Association Hall of Fame

Your dog must meet the criteria below to be eligible for the Induction into the Hall of Fame. When your dog has achieved the required number of Regional and/or Championship medals and you have completed the application form send the forms to the Hall of Fame Chairperson (refer to requirements below). Your certificate will be mailed to the address on the application form. Please complete all blanks on the form to aid in the processing of the certificates.

No active weight pulling dog will be inducted into the Regional or International Hall of Fame. The owner should not submit a request for induction until the dog is retired from weight pulling. This is open to any dog that has pulled in the IWPA and meets these qualifications, regardless of how long the dog has been retired.

## Requirements for Certificates

### International Hall of Fame

1. The dog must have won at least one wheel or snow International Championship Medal in 3 separate years (snow or wheel medals earned the same year are considered as 1 year).
2. Owner must submit a bio and achievements to the IWPA Hall of Fame Chairperson by May 1<sup>st</sup> which will vote and induct a maximum of 3 dogs per year into the International Hall of Fame. If the owner submits to have a dog inducted and it is not voted in, the owner can continue to submit in successive years. There is no limit to the number of times allowed for submissions.

### Regional Hall of Fame

1. A dog that wins a Regional Medal on wheels or snow in 5 separate years (wheels and snow in the same year are considered as 1 year) is automatically eligible for induction into the Regional Hall of Fame.
2. Owner must submit a bio and achievements to the Hall of Fame Chairperson after the dog has earned the requirements needed.

Digger has multiple titles in obedience, rally, agility and earth dog but the one thing I had never been able to teach him was to walk on a loose lead. Three years ago a friend, who has Norfolk Terriers, told me that she had been participating in weight pulling and that there was a great place to practice in Oneida, NY. I'm always looking for something new and different to do with my dogs. At that time Digger was only 7 and he had basically quit working in obedience and earth dog. His attitude was, I've done that, time to move on, so I thought "why not" let's give this a try. Borders typically live to 15 years of age so we had plenty of time to try something new.

In 2010 we went to Lisa's to watch the March trial and we participated in the Novice pull at the end of the day. Digger took right to it and was very happy to get told to pull, I don't think he ever looked back to see what was behind him. At the end of the 2010-2011 season he was invited to nationals and received a gold medal from

Region 5 from the 20# class. At the end of the 2011-2012 season he was again invited to the nationals and received a silver medal from Region 5. Digger had turned 9 in March and I was planning on retiring him at the end of the season. He didn't like to do a lot of turns so I had started pulling him for the first round on the large cart, 225#. He did his first pull on Sat. and on the second round he just sat down and seemed to say "okay, I've done this, what's next?" I've learned that once he has decided he's done, that's



it, and that was the end of his pulling career. In two seasons he earned multiple legs at the Working Dog level, 3 legs at the Excellent level and 1 leg at the Superior level, where he pulled 425# (26.5 x his weight) and earned the award for the highest percentage for that day.

I've owned Border Terriers for 35 years, they are great house dogs, wonderful companions, extremely versatile in a wide range of performance activities and above all they like to do it "Their Way".

We are now looking forward to our next adventure






HONORING THEIR “ULTIMATE SACRIFICE” and the other reading “IWPA REGION 9 2010-2011 HONORING THE FALLEN”.
