



Board Meeting Minutes via Zoom Meeting June 11th, 2022

Meeting called to order by President Terry Reed at 7:35 CT.

Roll Call – Those present via ZOOM video meeting President Terry Reed (1st term, 1st year), Vice President Sheryl Franklin (1st term, 1st year), Secretary to the Board Robbie Reed, Treasurer Cheryl Martin (2nd term, 2nd year), Rodney Martin (2nd term, 1st year), Trisha Porter (1st term, 1st year), Stephanie Stoll joined the meeting at 9:15 CT (1 year appointment), Diane Krupski joined the meeting at 9:15 CT (1 year appointment), Shirley Webber joined the meeting at 9:24 CT (1 year appointment). A quorum was met prior to the late attendances joining the meeting. Absent Sean Hammell (1st term, 2nd year). Guests Jean Wilson Sanctioning/Statistician Chair, Mary Felice, Clay Fonville, Connie Meech.

Meeting minutes previously approved after the 2021 board meeting. Minutes not read.

Secretary Report Robbie Reed – Written report submitted. Robbie Reed outlined voting that had taken place during the 2021-2022 season. No questions were asked by the board.

Treasurer Report Cheryl Martin – Written report submitted. Cheryl Martin said she needed to complete a couple financial transactions which are to deposit money from Promotions as well as needing to transfer money from savings to checking for the last 2 years for travel money that Robbie dispersed during championships. Jean indicated she had received an invoice for \$625.00 that is due for the club insurance which is due on August 1st, 2022 (for the 2022-2023 season). Cheryl reported she had a lot of PayPal use for payments of fees due to the club. Cheryl added she would like to mention postage has gone up and things mailed to Canada are very costly.

It should be noted, all committee reports were submitted prior to the meeting for everyone to review. President Terry Reed asked if there were any questions about any of the committee reports and there were none. The only chairperson missing was Jennifer Berning for Membership and Awards however, she did submit a written report. Motion made by Rodney Martin to accept all the committee reports as written. Seconded by Sheryl Franklin. MSCU

UNFINISHED BUSINESS

Newsletter review - Robbie Reed indicated she printed all the newsletters this season by using self-serve copiers at Office Depot. Robbie indicated printing hardcopy newsletters this season was \$49.02 an increase of \$10.85 over last season which is an increase of just over 28%. Postage has also increased and is due to increase again. This cost is for hardcopy newsletters only and does not cover any other printing such as the Constitution/By-Laws, Pulling Rules and etcetera. Robbie indicated under new business; the board will need to discuss membership fees.

Hall of Fame review – Robbie Reed reported all the outstanding Hall of Fame awards have been handed out and presented to the membership during the Awards Banquet at the Championships. The only Hall of Fame award submitted for review during the board meeting is for Ceasar with owner/handler Richard Felice. The application is for Regional and International Hall of Fame. Robbie reported she verified Ceasar has obtained the requirements needed for induction into the Hall of Fame for both Regional and International awards. Rodney Martin made a motion to accept and induct Ceasar into the Regional and International Hall of Fame. Trisha Porter second the motion. MSCU

Treasurer Bond amount review – After discussion for the bond amount, Sheryl Franklin made a motion to keep the bond amount at \$0.00. Trisha Porter second the motion. MSCU.

General Membership meeting discussion – President Terry Reed said Missy Kehler's topic asking, how can we get more membership and grow the club was a good topic. Missy Kehler did submit a letter to the board for additional discussion. She had three main topics within her follow-up letter to the board. These topics are included in this board discussion; Social Media Rep, Region alignment, and adding rails as a pull surface. Terry said Missy's idea of having a social medial person could be a great idea if the posts were monitored. Stephanie said she is an admin person on three Facebook pages and an admin person can approve posts prior to posting. That way posts can be monitored, and only appropriate posts would be approved.

The topic was about the newsletter being the official source of information and not the website. This is outlined in the By-Laws Article VII. This would be difficult to change following the requirement outlined in By-Laws Article VIII, Section 2. The board understands the website can be updated and members can see the updates very quickly. However, to change the means of

communicating association business shall remain in the newsletter.

Another topic that Missy Kehler talked about was region alignment. President Terry Reed mentioned the board would need to think about the expense to the organization in adding more regions. Trisha Porter brought up making Canada regions their own regions. She added because of breed specific legislation, she cannot enter Canada anywhere. The reality is, breed specific bans are not a regulation across Canada. However, it is location specific. Terry suggested having a committee work on region re-alignment and address that under new business.

Another topic is adding rails as a pulling surface. Things to consider for adding rails besides having the equipment, would be the number of days for Championships, and adding rails equipment. It would require having a three-day championship as well as having more weight. At the end of discussion, the board decided to survey the membership for adding rails pulling surface. One way of completing a survey could be on a IWPA Facebook page.

Terry mentioned an issue during championships was the starting weight and weight increments during the championships. Discussion was about possibly having a specific formula for figuring out both weights. After discussion, the board decided no rule change needed.

IRS/Not for Profit status. Trisha indicated she found the status had been revoked. She added we may need to hire an attorney to look at the history of the IWPA's status and determine what steps need to be taken next. Trisha added it is important for organizers to not advertise the pull was going for a non-profit and present it as the IWPA had a 501-C number so their donation of a prize would be able to be taken off taxes. The IRS/Not for Profit status not addressed.

PayPal review – Cheryl indicated the use of PayPal has been going well with no issues. The people using PayPal are the ones who pay for the use, not the IWPA.

COVID 19/PANDEMIC - Sheryl indicated no problems.

Tabled item for Board Meeting 2021 Lifetime Membership - Diane Krupski removed for this topic. Shirley Webber submitted for last board meeting a Lifetime Membership for Diane Krupski. Diane does meet the requirement for this. Shirley Webber, Stephanie Stoll, and Carol Gerke had all submitted letters. Rodney Martin made a motion to accept the nomination for Diane Krupski for a Lifetime Membership be granted. Second by Sheryl Franklin. MSCU

Diane Krupski said she did keep all the election ballets and envelopes and inquired if she needed to maintain them or discard them. No one wanted to audit the ballots, so Diane was instructed to discard them at this point.

Clay Fonville also submitted a letter for discussion at the board meeting. His topic covered weight class adjustments. Clay explained he separated sizes of dogs in the middle classes depending upon the percentage of body weight. However, he did not calculate the small and larger weight classes (under 80-pound weight classes). Jean suggested the IWPA not get carried away increasing the number of weight classes. Clay talked about most weight pulled, and most percentage award could also be awards. Terry explained those awards are from organizers not awards given by the IWPA. Individually, people can work to obtain Working Dog titles and Working Dog medals. The working dog titles/medals is a program sponsored by the IWPA.

Election of Officers (current and incoming board members present at the spring meeting are allowed to vote in officer elections per Standing Rule Article XIII Section 4).

Treasurer – Stephanie Stoll accepted the nomination. No other nominations made. Stephanie Stoll winner.

Trisha Porter leaves the meeting and does not return.

Proposed Budget – Stephanie Stoll to get with Cheryl Martin to evaluate the proposed budget. Then the board will re-visit and vote on the new budget.

Membership Dues review – After discussion, the board decided newsletters shall be distributed only by email as well as all documents that would be sent to members. Rails pulling surface – After discussion, the board decided to add a survey on the newly created Facebook page. Then discuss the outcome of the survey at the next board meeting (June 3-4, 2023).

Hall of Fame criteria – The board discussed championships that were canceled due to the pandemic, (2020 and 2021 seasons) and how that may affect the dogs toward the end of their careers and how those missing championship placements will affect the possibility of earning HOF inductions. After discussion, the board decided no changes are needed. And unfortunately, those years of earning championship medals is lost.

Weight Class review – The board discussed weight classes brought up by Clay Fonville. The board decided to survey the membership via the Facebook page about current weight classes.

Championship rotation Standing Rules, Article III, Section 8A – The board discussed the geographic rotation basis and the four Districts divided by regions. Shirley Webber made a motion for the following changes due to region alignment changes:

West - Regions 1, 2, 10, 12, and 13 Mid-West – Regions 3, 9, and 14 Mid-East – Regions 4, 6, 8, and 15 East – Regions 5, 7, 11, 16, 17, and 18



Tips to Protect Your Dog's Paws from Hot Pavement

Many owners like taking their dogs on walks to enjoy the warm summer weather with them, but many of them forget about one important detail: hot pavement can and will burn a dog's paws. It can be tempting to take your dog everywhere you go, but it can cause serious harm to your dog if you are not careful. Remember that if asphalt and cement can get hot enough to cook an egg during the summer or if it feels way too hot for you to leave your hands comfortably on the ground for at least 10 seconds, it can result in nasty burns on your dog's paw pads. This is especially true if you have a new puppy with tender young paws.

Here are some tips to keep your dog or puppy from getting burned this summer.

1. Walk Your Dog When It's Cool

This is probably an obvious tip but one that folks sometimes don't consider enough. It's a great idea to take your dog out on daily walks, but be mindful of when and where you walk him. The best time to walk your dog is in the morning or late evening, when the pavement is cool. Avoid walking your dog in the afternoon when the sun is high in the sky or early evening, because the pavement will be hot.

2. Toughen Your Dog's Paws

When it's time to walk your dog, it can actually be a good idea to stick to the pavement during the cool times of the day. While the pavement is cool, it won't burn your dog's paws, and it will also help to toughen them up. This will help to prevent any potential burns that could come later on.

3. Stay On The Grass

If you end up taking your dog out during the warmer times of the day, be sure to stay on the grass and stick to shady areas. Stay away from sidewalks or any paved areas to avoid burning. A shady park can be a great place to take your dog on a warm afternoon.

4. Moisturize Your Dog's Paws

Consider moisturizing your dog's feet daily to help prevent injuries like cuts, cracking, or peeling of the paws. Minor injuries like this can make your dog's paws more susceptible to burns and other serious problems.

5. Use Paw Wax

Paw wax can easily be smeared onto your dog's paw pads to protect them from harmful surfaces. Paw wax is designed to protect your dog's feet from hot surfaces and potentially harmful chemicals like road salts. (If you need something right away, you can try some Vaseline. It is not nearly as good but better than nothing.)

6. Dog Shoes

Dog shoes are one of the best ways to protect your dog's paws from heat and potential injuries if your dog will wear them. If this seems like the right solution for your dog, be sure to buy shoes that have rubber soles to offer the best protection. Be aware that not all dogs can get used to dog shoes, and some might have a hard time walking in them. There will definitely be an adjustment period for your dog with dog shoes. If you can get your dog used to using them, nothing else offers better protection. Disposable dog booties are a great short-term fix for the summer heat. Dog booties can provide good protection from the heat, and are a great temporary solution if you need to take your dog out on a hot day and your dog is willing to wear them.

7. Peel And Stick Pads

Peel and stick felt pads are a quick solution to minimize the dangers of hot pavement. They're easy to stick onto the pads of your dog's feet and they help protect against potential burns and injuries. They can even reduce the risks of your dog slipping on slick surfaces. And even better alternative to the felt pads may be silicone scar pads or tape. They are so easy to put on and they can be

cut to the perfect size for paws. They can be reused and they do well and stay on in wet conditions. They are so thin, flexible and durable that your dogs should not have any problems wearing them unlike many other things you put on their paws. Silicone scar sheets can be a terrific option for your dog's paws.

8. Socks

Socks are a decent last minute solution if you need to take your dog onto the hot pavement. Like dog shoes, not every dog will tolerate wearing socks. You can just take a pair of your old socks or little baby socks and see if they will work. You should be watchful when putting socks on your dog's feet, as some dogs will be tempted to chew them.

9. Check Their Paws Carefully

Be sure to check your dog's paw pads daily for any signs of damage and wash his paws frequently. If you do happen to see a problem, or if your dog is acting strangely on his feet, be sure to have him taken to the vet to see how bad the injury is.

How to Tell If Your Dog's Paws Are Hurting

Your dog's paws have footpads that can usually handle whatever a stroll or walk in nature throws at them. But a lot of human-made surfaces can burn your pooch's paws, including concrete, metal, pavement, sidewalks and asphalt.

Dogs showing these symptoms may have burned paws:

- Limping or avoiding walking
- Licking or chewing feet
- Paw pads are darker in color than usual
- Pads are visibly damaged
- Blisters or redness


First Aid for Burned Paws

If you suspect your dog has burned paw pads:

- Bring your dog inside right away. Carry your pet if necessary
- Flush the foot with cold water or use a cold compress
- Try not to let your dog lick the injured pad

Take your dog to the vet as soon as you possible because burns can become infected. Your dog might need antibiotics or pain medication depending on the severity of the burn. The vet can also rule out other possible causes of the symptoms. Paw licking can also be a sign of other problems, such as allergies.

These tips will help your dog stay safe and uninjured this summer from the dangers of hot pavement. Happy Summer!
