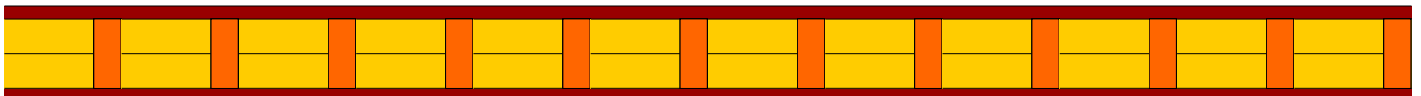

Thanksgiving Dos and Don'ts

Each year around the Thanksgiving festivities, there is an increase in urgent care visits to veterinary practices around the country. The increase is not because turkey is bad for dogs, but dogs cannot often tolerate the “trimmings” and other ingredients included in the dishes on the table, which can sometimes prove toxic.

The simple answer is yes, dogs can eat many Thanksgiving foods, including turkey, potatoes, sweet potatoes, and peas, but you should be sure to skip the turkey skin, stuffing, and other dishes that you are serving to humans. These foods often have additional spices, butter, and other ingredients that are too rich for dogs and can cause pancreatitis or other digestive ailments. Onions and garlic, in particular, can be very toxic to dogs. Always confirm that these ingredients are not added to any food that you are considering sharing with your dog.

Also, avoid giving your dog pumpkin pie. Plain cooked fresh pumpkin is fine to feed to dogs, but pumpkin pie filling often includes Xylitol which is very toxic and potentially deadly for canines. It is better to be safe and stay away from the pie; instead, make a fresh pumpkin treat for your dog. Just be sure to buy pure pumpkin and confirm that there are no added ingredients.

Consider writing or printing a list of foods you can share with your dog and inform your guests as well, so that you and your dog can enjoy a happy and healthy Thanksgiving. Be prepared. Post the phone number to the Pet Poison Helpline (855-764-7661), as well as the number and address for your local emergency veterinarian, in a place where all household members can see it.
