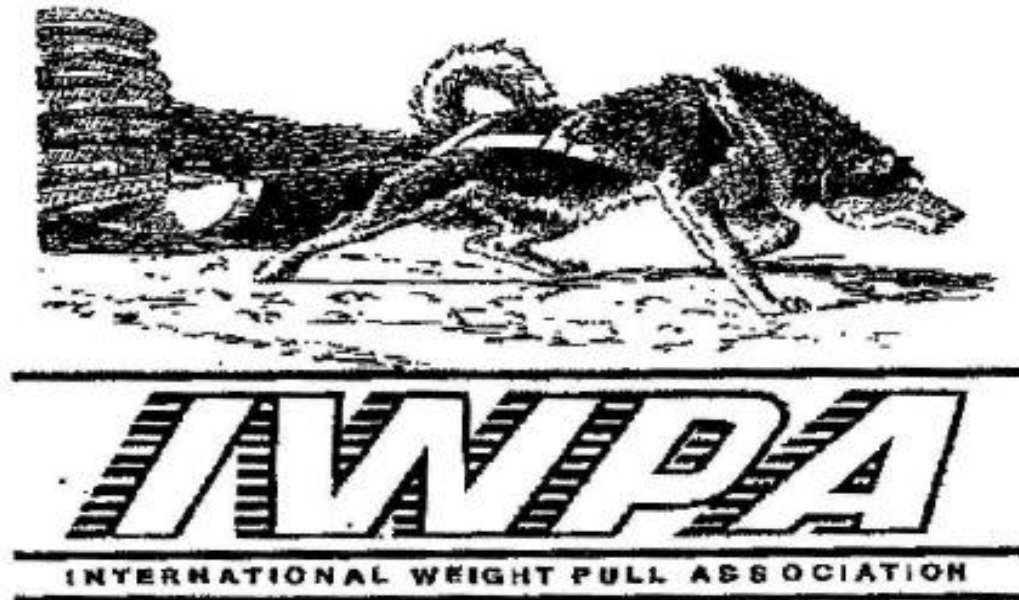

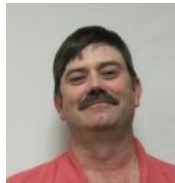

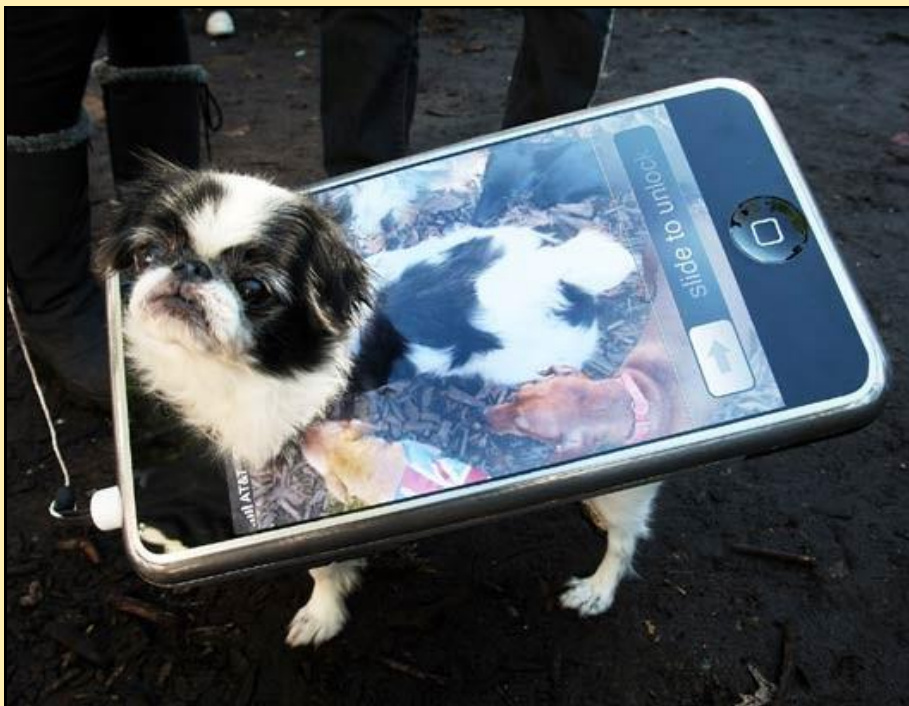

The fifth Annual Paws/Bark for Life Saturday morning brought together four legged friends and their humans to fund-raise for Relay for Life. Dogs large and small came out and enjoyed a pulling demonstration from International Gold Medalist “Stormy”.

“A lot of people want to bring their dogs out to Relay for Life but we're not really situated for that there so lets have a Relay for Dogs” Paws/Bark for Life Founder Sandi Coke said. “People who enjoy dogs can come out and have a fun time with their dogs and still raise money for American Cancer Society.”

The event raised \$7,000.00 on Saturday. Over the past 5 years Bark for Life has raised an estimated \$50,000.00 for the American Cancer Society and cancer research.

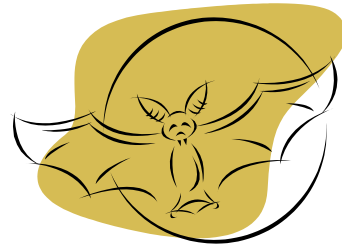

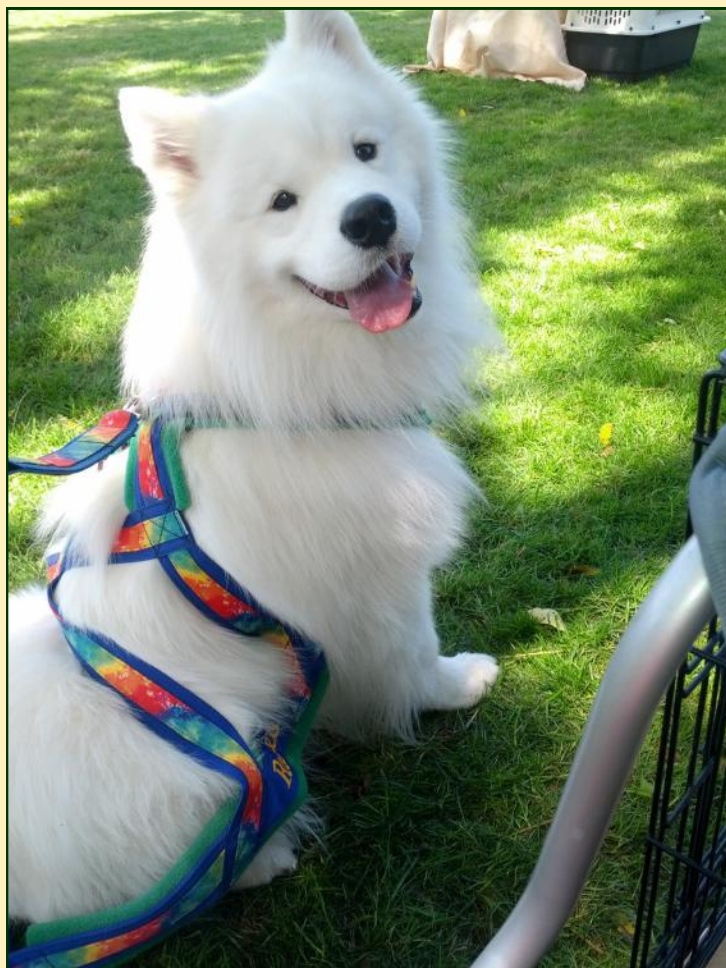

Joey's Jerky Chicken Jerky Treats Recall

September 10, 2013 — The New Hampshire Department of Health and Human Services (DHHS) [has announced a voluntary recall](#) of Joey's Jerky Chicken Jerky treats due to possible contamination with **Salmonella** bacteria.

A total of 21 people in Merrimack and Hillsborough Counties have been identified with the same strain of the illness. However, no deaths have occurred.

Joey's Jerky is produced in New Hampshire and the manufacturer, Kritter's Kitchen Kreation, LLC, has voluntarily recalled all of the product.



Joey's Jerky was sold at the following six stores:

- America's Pet in Hudson
- Blue Seal in Bow
- K9 Kaos in Dover
- Osborne's Agway in Concord
- Sandy's Pet Food Center in Concord
- The Yellow Dogs Barn in Barrington

Confirmation through laboratory testing of the jerky is pending at the New Hampshire Public Health Labs.

What to Do?

DHHS is asking people to determine if they have any of these jerky treats at home — and if so, to **discard them**.
