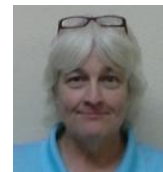

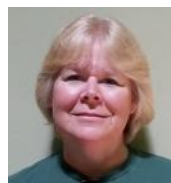

The Election for Board Members for our organization and the 2018 Championship Judges is fast approaching.

According to our By Laws,

Nomination Committee - Added to Article XI Section 1 a second sentence which reads, "Any member in good standing who is interested in serving on the Board of Directors may communicate that interest to the Elections Chair person, who is serving as the Chair of the Nominating committee. That information and a brief bio must be received by the election chair on or before November 15th.

The December issue of the newsletter will list the candidates with their bios that have been submitted to the elections chair. The election will take place in January with the closing of ballots received on or before February 15th. The elected directors shall take office immediately upon the conclusion of the old business at the annual board meeting (usually held in June).

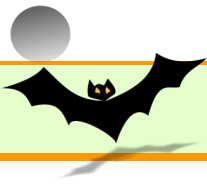
There are nine (9) members on the board. The board of directors shall be elected for two year terms. No board member may be elected for more than two consecutive terms without a vacation of at least one term. Terms are staggered so that the terms of no more than five (directors) shall expire in any year.

For this coming election, there are five (5) openings. Four positions are current board members who would be running for a 2nd term. If they are interested in continuing on the board, they need to relay their intention to the Election Chair and provide a bio.

Please consider serving on the board. If you have an interest and want to be part of the governance of the IWPA organization, contact the Election Chair or any current Board member by November 15th.

- 3 – 5 TB Coconut Oil

Strawberry Banana Frozen "Yogurt"

Ingredients

- 1 1/2 cups whole frozen strawberries
- 2 frozen bananas

1. Blend strawberries, bananas and oil together. You want this to be thick, like soft serve ice cream. If too thick, add water.
