

Dear Organizer:

Enclosed is your sanctioning packet. The I.W.P.A. would like to congratulate you on your pull. We hope that your pull is successful. The I.W.P.A. has enclosed some forms and information that will help you with your event. We believe in giving you more than just a set of rules.

In order for a dog to compete in an I.W.P.A. event, the owner must be an I.W.P.A. member. The I.W.P.A. does provide a provisional membership for the puller that does wish to be a member for the pull only. The provisional membership cost is \$5.00 per **DOG**, per event, paid in US currency. The provisional member does not receive points for their dog. However, their dog does count for points for I.W.P.A. members.

- 1 Judges report form **RETURN TO JUDGE'S CHAIRPERSON**
- 1 Membership application (make copies as needed) **RETURN TO MEMBERSHIP DIRECTOR**
WITH MEMBERSHIP FEES paid in US currency.
- 1 Membership receipt: to be given to new member when they join as proof of membership until they receive their card and are on the list (make copies as needed)
- 1 Provisional Membership Application (make copies as needed)
- 1 Rule pamphlet (make copies as needed)

Please send only 1 check for your pull, from the organizer. Multiple checks from various members will not be accepted!
